1. I/we, have read and reviewed Chapter 3701-28 of Ohio Administrative Code and understand the provisions contained therein.
2. I/we, the undersigned, hereby agree to comply with the state private water system rules, Chapter 3701-28 of the Ohio Administrative Code.
3. I/we, assert that I/we have adequate experience and knowledge to comply with the requirements Chapter 3701-28 of the Ohio Administrative Code.
4. I/we, assert that I/we are not using this registration application to aid or abet an unregistered person to evade the requirements of registration under section 3701.344 of the Ohio Revised Code, that I/we will not allow this registration to be used by an unregistered person, or am acting as an agent, partner, or associate of an unregistered person with the intent to evade the provisions of Chapter 3701-28 of the Ohio Administrative Code.
5. I/we, also acknowledge that registration may be suspended, revoked or denied for violation of any provisions of these rules.
6. I/we attest that this registration is requested for work on the private water system for my primary residence.

## Fee Variance Request

Ohio Administrative Code (OAC) rule 3701-28-18 (A)(2) requires owners of a primary or secondary property, or property rentals in which they do not reside, or owners, altering or sealing water wells for their dwelling house to obtain a registration to perform work. OAC rule 3701-28-18 (B)(1)(a) requires a \$250 registration fee (payable by check or money order to "Treasurer, State of Ohio") for registration as a Private Water Systems contractor.

I am the owner (designee/ responsible party) of the property identified as the "Property On Which Work Is Being Done" on the face of this document and respectfully request a reduction of the required fee from \$250.00 to \$50.00 because I am constructing, altering, or sealing (circle applicable action) the private water system on my personal property. The term "constructing" includes any aspect of the work being done to establish a well, pond, spring, cistern or hauled water storage tank as a source of potable water, including installation of a pitless adapter on a well casing.

In anticipation of a favorable response to this request submitted under the provisions of OAC rule 3701-29-19, which permits the Private Water Systems program to consider and grant variances, I agree to become registered as a Private Water Systems Contractor for a fee of fifty dollars (\$50.00) for the purpose of performing the work on the private water system. I understand my registration is limited to a one-time registration for the tasks I wish to perform on my private water system.

## Bond Variance Request

Ohio Administrative Code (OAC) rule 3701-28-18 (A)(2) exempts owners of a primary or secondary property, or property rentals in which they do not reside, or owners, **altering or sealing water wells** for their dwelling house from bonding requirements. OAC rule 3701-28-18 (B)(1)(b), however, require Private Water Systems contractors to submit a \$20,000 bond in order to register.

I am the owner (designee/ responsible party) of the property identified as the "Property On Which Work Is Being Done" on the face of this document and respectfully request a variance from the bond requirement because I am **constructing**, a private water system on my personal property. The term "constructing" includes any aspect of the work being done to establish a well, pond, spring, cistern or hauled water storage tank as a source of potable water, including installation of a pitless adapter on a well casing. Property owners drilling their own well are required to obtain a \$20,000 bond.

In anticipation of a favorable response to this request submitted under the provisions of OAC rule 3701-29-19, which permits the Private Water Systems program to consider and grant variances, I agree to become registered as a Private Water Systems Contractor for the purpose of performing the work on the private water system. I understand my registration is limited to a one-time registration for the tasks I wish to perform on my private water system.
